- A seller's permit or business license is required. If you are selling food items, you are required to have the appropriate permit from the Sacramento County Environmental Management Department (EMD). Acceptable permits are: Temporary Food Facility Permit (TFF), Multi-Event Food Permit (MEV), or Mobile Food Facility Permit (MFF). **You will need your permit displayed on the day of the event.**
- Get your sellers permit by logging onto the CA.gov website. The permit is free but is required for registrations and needs to be available at your booth on the day of the event.

No firearms, weapons of any kind, alcohol or drugs. This event is partially outside, the craft fair will take place regardless the weather or air quality. If your space is on the grassy area, please bring some sort of temporary flooring because the ground could be damp. Suggestions are plywood, card board boxes, tarps, etc. Inside spaces are limited. Spaces will be assigned by the event coordinator.

### **Agreement, Waiver, & Release Form**
